Students participate in both one-on-one activities in their buddy pairs and in group events to allow for optimal engagement and interaction for all members. Elementary school program growth has accelerated throughout 2024, with 585 chapters worldwide with 16,129 members. This is the fastest growing friendship program in the history of Best Buddies!

Middle Schools: The Middle School program continues to thrive with 685 schools participating in Best Buddies with 13,619 members engaged worldwide. The Best Buddies Middle School program has maintained growth throughout the year and has positively benefitted from expansion efforts at the elementary school level which increase the pipeline of volunteers moving into middle school. Supported by chapter advisors, every school club is led by two students one with a disability and one without a disability and all members participate in events and group activities throughout the year, offering friendship pairs onsite support and the opportunity to socialize with other program participants.

Colleges: In 2024, the Best Buddies College program connected 522 colleges and universities across the globe, engaging 21,755 active members.
